4. Your personal information requested on the Application will be kept confidential. We are requesting this information to give us a demographic of the Veterans and Families we minister too. Here is an example of how we may use your information:

We had 49 Veterans visit Pathfinder's Equine this year 27 of those had families with an average of 3 children per household. 16 of those families currently attend church regularly but nearly everyone was eager to learn more about what the Bible says about War and PTSD.
